State Survey Results of LTC Facilities: Recorded Trends

Our review of the last quarter State Survey identifies the following areas as having frequently cited deficiencies:

F281 Professional Standards of Practice

Resident not being instructed to blow nose in order to clear nostrils prior to inserting Flonase nasal spray.

F323 Accidents

Need for staff education on how to unlock resident bathroom doors in case resident is locked in.

F332 - Medication Errors

- Medication not timed appropriately with meals.
- Medications not adjusted for dialysis.
- Surveyors finding patches have not been removed from previous shift.

F425 - Pharmacy Services

Facility must have a policy and procedure for return of non-controlled medications awaiting pharmacy pick-up.

F431- Labeling of Drugs & Biologicals

Lockbox in refrigerator attached to shelf but not affixed to refrigerator. Surveyors feel that the shelf with the lockbox can be removed.

F441 - Infection Control

• Handwashing technique: make sure that by friction, enough lather is generated before rinsing.

• Glucometers not being cleaned between uses.

Additionally, please note:

- ➤On several occasions, we have seen that surveyors have been observing <u>all</u> nurses on duty during the medication pass rather than just a small, random sampling.
- Some hospice care companies are prescribing Atropine 1% ophthalmic drops sublingually to control excessive secretions. Make sure that the order is written clearly and indicates *"for secretions"* rather than *"for the eye"* in order to avoid confusion.

EPIC Updates

Avoid Coumadin Complacency

Did you know that Coumadin (warfarin) composes 50 % of the top ten drug interactions in long-term care?

► Remember to monitor for the adverse effects of Coumadin when administering non-steroidal anti-inflammatory drugs such as ibuprofen.

 Sulfa drugs, macrolide antibiotics and quinolones may increase the effect of Coumadin.
A PT/INR should be obtained when the resident is receiving a course of these antibiotics.

► The interaction between warfarin and phenytoin is very complex. An immediate interaction may occur as phenytoin can displace warfarin from protein binding sites causing rapid increases in the INR. After prolonged administration, phenytoin may reduce the effectiveness of warfarin by inducing the metabolism of warfarin. Competitive inhibition may also occur since phenytoin and warfarin are both substrates for cytochrome P450 2C9. Phenytoin also may deplete vitamin-K dependent clotting factors after prolonged therapy. Warfarin dosage adjustments may be necessary if phenytoin is added. Warfarin may alter phenytoin serum concentrations as well.

■ Lilly has introduced **Humulin N** in a **3mL** size vial. Humulin R and Humalog are already available in 3mL vials. The smaller vials have the same color differentiating system as the 10 mL vial. Because of the 28 day expiration on insulin, the 3mL vials prevent waste and are more cost-effective for lower dosing. Make sure the prescriber requests the 3 mL vial when writing the order.

 Did you know that some insulins are good for longer than 28 days? Levemir, NovolinN, Novolin R and Levemir flex pens are good six weeks (42 days) after opening.

■ According to the Clarion-Ledger of Mississippi, a new study is showing promise in creating a device that can detect **MRSA** in less than 15 minutes. The study, a partnership between QuantaLife and the University of Mississippi Medical Center, will be testing a third generation machine that is hoped to give results in less than 15 minutes at a cost of \$2. The new method would require just a swab of specimen from the patients nose. In addition to the ease of testing, the machine would be as small as a microwave making it
