Cautionary Labels in LTC

- Actonel (Risedronate) Administer with 8 ounces of plain water, at least 30 minutes prior to all other food, beverage or medication of the day, remain upright for 30 minutes after administration
- Advair (Fluticasone/Salmeterol) Administer every 12 hours; rinse mouth after use
- 3. **Calcium supplements** Take with food or meals, separate from iron by 2 hours
- 4. Carafate (Sucralfate) Take on an empty stomach
- 5. **Cipro (Ciprofloxacin)** Administer 2 hours before or 6 hours after: antacids, sucralfate, products containing calcium, iron, zinc. Encourage extra fluids (unless contraindicated), monitor for dizziness & tendonitis
- Colace liquid (Docusate Sodium) Mix with 6-8 ounces of milk or fruit juice to mask bitter taste & prevent throat irritation
- 7. Coreg (Carvedilol) Administer with food
- 8. **Coumadin (Warfarin)** Monitor for bleeding or bruising
- 9. **Ecotrin (Aspirin)** Do not crush. Take with plenty of water
- 10. **Flomax (Tamsulosin)** Administer ½ hour after the same meal daily, do not crush, open or chew capsule
- 11. **Fosamax (Alendronate)** Administer with 8 ounces of plain water, at least 30 minutes prior to all other food, beverage or medication of the day, remain upright for 30 minutes after administration

- 12. Glucophage (Metformin) Take with meals
- 13. Glucotrol (Glipizide) Administer 30 minutes prior to meals
- 14. **Imdur (Isosorbide Mononitrate ER)** Administer in the morning upon awakening, do not crush
- Lopressor (Metoprolol) Take with or immediately following meals
- 16. **Lovenox (Enoxaparin)** Administer subcutaneously in the abdomen, rotate sites, monitor for bleeding or bruising
- 17. **Nexium (Esomeprazole)** Take at least one hour before meals
- Potassium supplementsTake with meals and a glass of water or other liquid
- 19. **Prandin (Repaglinide**) Administer immediately preceding the meal to as long as 30 minutes before the meal
- 20. **Prilosec (Omeprazole)** Take on an empty stomach before eating
- 21. **Spiriva (Tiotropium)** Inhale twice from the same capsule to receive the full dose
- 22. **Synthroid (Levothyroxine)** Administer on an empty stomach, preferably before breakfast, separate by 4 hours from iron, calcium, magnesium & aluminum containing products
- 23. **Tylenol (Acetaminophen)** Do not exceed 4.0 grams daily from all sources
- 24. **Xarelto (Rivaroxaban)** 15mg and 20mg tablets Take with food (if prescribed for diagnosis of atrial fibrillation, must be administered with evening meal)
- 25. **Zocor (Simvastatin)** Administer in the evening

Check with specific pharmacy providers as the preprinted precautions may differ from the package insert.

Changes to CMS Five Star Quality Rating System and the Use of Antipsychotics

Among the new quality measures that have been added to the CMS' Five Star Quality Rating System for nursing homes as of February are two regarding short and long-stay antipsychotic use.

Long Stay- For the long-stay antipsychotic medication quality measure, facilities are divided into five groups based on the national distribution of the measure: the topperforming 10 % of facilities receive 100 points; the poorest performing 20% of facilities receive 20 points; and the middle 70% of facilities are divided into three equally sized groups (each including approximately 23.3 percent of

nursing homes) and receive 40,60, or 80 points.

Short Stay - The short-stay antipsychotic medication quality measure is treated similarly, however, because approximately 20 % of facilities achieve the best possible score on this quality measure (i.e. zero percent of residents triggering the quality measure), these facilities all receive 100 points; the poorest performing 20 % of facilities receive 20 points; and the remaining facilities are divided into three equally sized groups (each including approximately 20 % of nursing homes) and receive 40, 60, or 80 points.

EPIC Reviews and Resident Charts

As per the NJ Administrative Code, please be aware that EPIC reviews should be added to resident's charts:

N.J.A.C. 8:39-30.2 (2015)

"The consultant pharmacist reviews drug records within 48 hours of admission via facsimile service. All dated and signed comments and recommendations made by the consultant pharmacist shall be added to the resident's **medical record** and shall be distributed to the attending physician or advanced practice nurse and director of nurses for review and action."

Adverse Drug Reactions

Adverse drug events (ADEs) are defined by the Institute of Medicine (IOM) as "injuries resulting from a medical intervention related to a drug".

Institutionalized elderly experiece ADEs at a rate as high as 10.8 events per 100-patient months, often as a result of polypharmacy, multiple comorbid illness, and difficulty with monitoring prescribed medications. This translates into approximately 135 ADEs each year in an average size nursing home (NH; bed size of 105) or approximately 2 million events a year among all U. S. nursing home residents.

Adverse drug events represent the most clinically significant and costly medication-related problems in nursing homes and are associated with 93,000 deaths a year and in as much as \$4 billion of excess healthcare expenditures. Despite the consequences and costs associated with adverse drug events, the vast majority of these events go undetected.

- Adverse drug events increase hospital stays between 8 to 12 days.
- Some signs of a possible adverse drug event include rash, changes in respiratory rate, heart rate, hearing or mental status, seizure, anaphylaxis, diarrhea or fever.
- Medications associated with adverse drug events include warfarin, insulin, phenytoin, digoxin, and opioids.

Professional practice insists one continue to hone their skills daily. Practice, although it does not always make perfect, helps the practitioner remain alert to these possibilities.
